MSPO Awareness Course for Technical Expert

Course Introduction

MSPO underwent significant changes with the launch of MS 2530:2022 on 22 Mar 2022. The new version of the Malaysian palm standard is also known as MSPO 2.0. The changes were made to ensure that the MSPO was acceptable to global market to create more opportunity for Malaysian palm products to be recognized internationally.

Therefore, the aim of this 3-days course is to prepare participants to become competent Technical Experts and to understand MSPO Principle and Criteria. The interpretation and application of MSPO regulations, as well as specific legal and MSPO 2.0 in accordance with the requirements, will be the main topics of this course. This program has been endorsed by MSPO to qualify participants as technical experts based on the MSPO Certification Scheme Document. The program complies with applicable accreditation requirements for certification bodies.

Course Objective

- 1) The primary goal is for participants to become competent as technical Expert in the methods specified in the MSPO Certification Scheme Document.
- 2) Exposure to the fundamental concepts & principles of MSPO standard requirements.
- 3) Plan & development of an MSPO Management System to meet MS 2530:2022 Standard
- 4) Obtaining a practical method to upgrade the management system to the requirements that meet the MSPO 2.0 Standard
