ISO 9001:2015 Internal Audit Training

Program Overview

Audit is an evidence gathering process. Audit evidence is used to evaluate how well audit criteria are being met. Audits must be objective, impartial, and independent, and the audit process must be both systematic and documented. Internal audits are referred to as first-party audits. Organizations use internal (first party) audits to audit themselves for internal purposes. Company can use first party audits to declare that organization complies with the subscribed standards (e.g ISO 9001, ISO 14001 or ISO 45001).

In the context of this quality management standard, an auditor is a person who collects evidence in order to evaluate how well quality management systems meet requirements. Auditors are expected to determine whether quality management systems comply with standards and other planned arrangements. They must also be able to determine whether quality management systems are properly implemented and maintained. And they must be able to do all of this while being independent, objective, impartial and competent.
