MSPO Supply-Chain and Traceability System

Course Overview

The Malaysian Sustainable Palm Oil Supply-Chain and Traceability System covers management system requirements and traceability of the production throughout the supply chain from the raw materials to processing and manufacturing of palm oil and palm oil-based products. Each group of players must perform their respective roles and undertake responsibility to enable traceability of all activities throughout the palm oil supply chain.

The course focuses on the application of the MSPO supply-chain systems and practice requirements to ensure consistent and appropriate implementation according to the standard. It covers key topics including the requirements of different supply chain models (i.e. Segregation and Mass Balance), multi-site and group certification requirements, claims and logo use tracking and trading of certified palm oil: MSPO Trace
