### MSPO-RSPO Awareness Training

#### *Course Overview*

Roundtable on Sustainable Palm Oil (RSPO) is a global multi-stakeholder association made up of players along the palm oil value chain such as oil palm growers, processors, traders, consumer goods manufacturers, social & environmental non-governmental organization, retailers, banks and investors, academic institutions.

The Malaysian Sustainable Palm Oil (MSPO) Certification Scheme is the national scheme in Malaysia for oil palm plantations, independent and organised smallholdings, and palm oil processing facilities to be certified against the requirements of the MSPO Standards.

The MSPO-RSPO awareness training is aimed at bringing participants to understand the MSPO & RSPO certification scheme, Principles and Criteria (P&C) and equip them with deeper understanding of both standards of sustainable production and supply chain requirements for implementation of sustainability requirements.

Sustainability personnel, Internal Auditor etc.

- 1) Participants understand how MSPO & RSPO certification scheme and systems can be integrated to ensure the effectiveness of implementation.
