### ISCC EU & ISCC CORSIA Awareness Training

#### *Acknowledgement*



ISCC is a globally applicable sustainability certification system and covers all sustainable feedstocks, including agricultural and forestry biomass, circular and bio-based materials and renewables.

ISCC EU certification provides proof of compliance with environmental, social and traceability criteria, and qualifies biofuel or biomass companies for legal recognition under the targets set by European regulations for transportation fuels. Any type of biomass-based fuel is eligible for ISCC certification.

While ISCC CORSIA is a voluntary scheme eligible for Sustainable Aviation Fuel (SAF) certification, as it meets the requirements of CORSIA (Carbon Offsetting and Reduction Scheme for International Aviation), which has been provided by ICAO (International Civil Aviation Organization).

#### *Training program overview*

The training program will focus on ISCC sustainability principles to aims at the implementation of highest sustainability requirements including ecological sustainability, social sustainability, compliance with laws and international treaties, monitoring of carbon emissions (life cycle emission) and good management practices.

The program emphasizes on the understanding of RED II that compulsory for compliance in the auditing program and also new ISCC scheme, the Sustainable Aviation Fuels Certification namely as ISCC CORSIA that focused on Aviation Sector.

## *Training Objectives*

1. Meeting with ISCC EU and ISCC CORSIA requirements to make participant aware and understand on the certification scheme and concept.
2. To refresh the participants the relevant activities required in complying with sustainability standard in alignment with the applicable Principles and Criteria requirement.
